

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.1078.18 lakhs (Rs. Ten crore seventy-eight lakh and eighteen thousand) only to the State of **West Bengal** towards the first (3) & second (3) instalment of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
