

I am directed to convey the sanction of the President of India to the payment of Rs.14.17 lakhs (Rupees Fourteen lakh & seventeen thousand only) to the **UT of Puducherry** towards the third instalment (1) of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.
