

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.7.50 lakhs (Rs. Seven lakhs and fifty thousand) only to the States of West Bengal towards the fourth instalment of grants-in-aid for implementation of Infrastructure Maintenance (Training of MPWs), a Centrally Sponsored Plan Scheme during 2012-13.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-1/76 dated 22nd January, 1977 and is to be paid in Cash.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.


