

I am directed to convey the sanction of the President to the payment of Grants-in-aid of **Rs.478.29 lakhs** (Rs. four crore seventy-eight lakhs and twenty nine thousand) only to the State of **Uttar Pradesh** towards the fourth instalment of grants-in-aid for implementation of Infrastructure Maintenance (Urban Revamping Scheme), a Centrally Sponsored Plan Scheme during 2012-13.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.


