

Sir,

I am directed to convey the sanction of the President of India to the payment of Rs.133.55 lakhs (Rupees One crore thirty-three lakh and fifty-five thousand only) to the State of **Bihar** towards the third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Urban Family Welfare Centres), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Schemes (Sub-Major Head); 244 - FW-Direction & Administration (Minor Head); 03-Infrastructure Maintenance (Sub Head); 03.03 Urban FW Centres; 03.03.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2013-14 (Plan).
