

I am directed to convey the sanction of the President of India to the payment of Rs.4.50 lakhs (Rupees Four lakh and fifty thousand only) to the State of **Bihar** towards the third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Training of MPWs), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Schemes (Sub-Major Head); 244 - FW- Direction & Administration (Minor Head); 03-Infrastructure Maintenance (Sub Head); 03.07- Training of MPWs; 03.07.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2013-14 (Plan).
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
