

I am directed to convey the sanction of the President of India to the payment of Rs.7.05 lakhs (Rupees Seven lakh and five thousand only) to the State of Bihar towards the third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Schemes (Sub-Major Head); 796 - Scheduled Tribe Sub-Plan (Minor Head); 03 - FW - Direction & Administration (Sub-Head); 03.02-I.M.-Maintenance of State/Distt. FW Bureaux; 03.02.31- Grants-in-aid - General in Demand No.47 – Health & Family Welfare during 2013-14 (Plan).
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
