



Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid of **Rs.0.67 lakhs** (Rs. Sixty seven thousand) only to the States of **Uttar Pradesh** towards the fourth instalment of grants-in-aid for implementation of Infrastructure Maintenance (Urban Revamping Scheme), a Centrally Sponsored Plan Scheme during 2012-13.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Scheme (Sub-Major Head); 796 - Schedule Tribes Area Sub-Plan (Minor Head); 05 - FW-Urban Family Welfare Services (Sub-Head); 05.02 – Urban Revamping Scheme; 05.02.31- Grants-in-aid – General in Demand No.46 – Health & Family Welfare during 2012-13.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
5. This sanction issues with the concurrence of Finance Division vide Dy. No C-1848 dated 26.02.2013.


