

I am directed to convey the sanction of the President of India to the payment of Rs.792.12 lakhs (Rupees Seven crore ninety-two lakh and twelve thousand only) to the State of **Gujarat** towards the first & second instalments of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
