

I am directed to convey the sanction of the President of India to the payment of Rs.5357.22 lakhs (Rupees Fifty-three crore fifty-seven lakh and twenty-two thousand only) to the State of **Gujarat** towards the first & second instalments of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
