I am directed to convey the sanction of the President to the provisional payment of Grants-in-aid of Rs.73.33 lakhs (Rs. Seventy three lakh and thirty three thousand) only to the **UT of Puducherry** towards the first instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
