I am directed to convey the sanction of the President to the provisional payment of Grants-in-aid of Rs.14.17 lakhs (Rs. Fourteen lakh & seventeen thousand) only to the **UT of Puducherry** towards the first instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.
