

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Scheme (Sub-Major Head); 244 - FW- Direction & Administration (Minor Head); 03-Infrastructure Maintenance; 03.07- Training of MPWs (Sub Head); 03.07.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2013-14.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
