Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.22.09 lakhs (Rs. Twenty two lakh and nine thousand) only to the States of Assam towards the first instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance (Maintenance of HFWTCs), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Scheme (Sub-Major Head); 244 – FW-Direction & Administration (Minor Head); 03-Infrastructure Maintenance; 03.06-Health & FW Training Centres (Sub Head); 03.06.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2013-14.
