
Subject: Family Welfare Programme - Release of First instalment (2) of Grants-in-aid for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during 2013-14 – **Training of MPWs**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.15.90 lakhs (Rs. Fifteen lakh and ninety thousand) only to the State of **Mizoram** towards the first instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance (Training of MPWs), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Scheme (Sub-Major Head); 244 - FW-Direction & Administration (Minor Head); 03-Infrastructure Maintenance; 03.07-Training of MPWs (Sub Head); 03.07.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2013-14.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
