

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.22.09 lakhs (Rs. Twenty two lakh and nine thousand) only to the States of Assam towards the second instalment of grants-in-aid for implementation of Infrastructure Maintenance (Maintenance of HFWTCs), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.


