

I am directed to convey the sanction of the President to the provisional payment of Grants-in-aid of **Rs.16.90 lakhs** (Rs. Sixteen lakhs and ninety thousand) only to the **UT of Puducherry** towards the third instalment of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2012-13.


