- 5. It should be ensured that every selected candidate carries <u>duly attested documents</u> including his/her photographs when reporting for admission.
- 6. Intimation whether all the seats allocated to that Ministry have been fully utilized should be conveyed to this Department on most urgent basis. In the event of any default in this behalf, this Ministry may have no choice except to curtail the allocation, to the extent of the seat(s) lost or un-utilized, in the succeeding year.
- 7. The two seats allocated to the Ministry of Women and Child Development should go to the eligible National Bravery awardees.
