If any of the allocated seats is not utilized, the same may be surrendered to this Ministry before two 8. weeks from the last date of admission, as notified by NMC/Dte.GHS.

In case, any seat remains unutilized and this Ministry is not informed forthwith, this Ministry may 9. have no choice but to curtail the allotment of seats in the succeeding years.
