

The above amount is granted for implementation of the National Iodine Deficiency Disorders Control Programme in accordance with the instructions issued by the Ministry Finance-plan Finance Division vide their O.M.No. 10(1) PF-1/76 dated 22.1.77. The amount may be paid by issuing cheque in favour of the Finance Secretary, Government of National Capital Territory of Delhi.

3. The expenditure covered by this sanction is debitable to Major Head "3602"-Grant-in-aid to the Union Territory Governments-03-Grants for Central Plan Scheme (Sub Major Head)-03263 (Minor Head)-Public Health-Prevention and Control of Diseases-02- National Iodine Deficiency Disorders Control Programme – 020031- Grants –in-aid (plan) under Demand No.46- for the year 2011-2012(Plan).

4. The payment sanctioned under para (1) above is provisional subject to the adjustments on the basis of audited figures of expenditure in terms of the Ministry of Finance letter No.2(19)P-II/60, dated 9.10.1964 and 6(68)-P1/89 dated 13.3.1975 and 6(26)-P1/75 dated 22.03.1983.

5. The State Government is requested to kindly note that the subsequent quarterly release of grants will be contingent upon the receipt of expenditure statements of the previous quarters and Utilisation Certificates for the previous year from them and the unspent balance remaining at the end of previous financial year is adjusted/ correspondingly reduced while sending the fresh proposals for release of the grants-in-aid, in future.
