It has been decided to renew the empanelment of **"Dhir Hospital, Meham Chowk Circular , Road, Bhiwani Haryana"** under CS (MA) Rules, 1944 for a period of 02 years from the date of signing of fresh MOU on the same terms and conditions laid down in O.M. No. S. 14021/67/2019-EHS dated 08th December, 2020.

2. The hospital stands re-empanelled under CS (MA) Rules, 1944 for a period of 2 (two) more years from the date of issue of this O.M.

3. The authorities of **"Dhir Hospital, Meham Chowk Circular, Road, Bhiwani Haryana"** will have to enter into a fresh agreement with the Government of India to the effect that the Hospital will charge from the Central Government employees at the rates fixed by the Government and they will have to sign a fresh Memorandum of Understanding (MoU) failing which the Hospital will be de-recognized (two original copies of MoU duly signed by the Hospital to be sent for acceptance). Subject to above, the Hospital can start treating Central Government employees covered under CS (MA) Rules, 1944.
