

NOTIFICATION

This Ministry is examining a proposal for amendment to the Recruitment Rules for the post of **Nursing Adviser, Assistant Director General (Nursing), Deputy Assistant Director General (Nursing) and Deputy Nursing Adviser** in the Dte. GHS. In this regard, draft Recruitment Rules have been prepared and approved by the Competent Authority.

Before taking up the proposal for amendment to the Recruitment Rules with the DoP&T, UPSC and other agencies for finalizing the Recruitment Rules, comments, if any are invited from all stakeholders in the matter within a period of thirty days from the date of notification in the website of the Ministry of Health and Family Welfare. G.S.R. No.....In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate General of Health Services (Nursing Officer) Recruitment Rules, 1982; the Department of Family Planning (Nursing Adviser) Recruitment Rules, 1977 except as respects things done or omitted to have been done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Nursing Stream in the Directorate General of Health Services, Department of Health and Department of Family Welfare in the Ministry of Health and Family Welfare, namely:-

1. Short title and commencement. - (1) these rules may be called the Ministry of Health and Family Welfare, (Nursing Stream), Recruitment Rules, 2022.

(2) They shall come into force on the date of their publication in the Official Gazette.
2. Number of post, classification, and scale of pay- The number of said post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule I, II, III and IV annexed to these rules.
3. Method of recruitment, age-limit and other qualifications etc. - Method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
4. Disqualification. - No persons,-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt such person from the operation of this rule.
5. Power to relax. - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
6. Saving. - Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the central Government from time to time in this regard.
