- G.S.R.... In exercise of the powers conferred by proviso to article 309 of the Constitution, and in supersession of the Safdarjung Hospital /Dr. RML Hospital/Lady Hardinge Medical College and Smt. S. K. Hospital/ Jawahar Institute of Post Graduate Medical Education and Research, Pondicherry /Central Institute of Psychiatry , Ranchi (Chief Nursing Officer), Recuitment Rules , 1999, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Chief Nursing Officer in the Dr. Ram Manohar Lohia Hospital ,New Delhi, Ministry of Health and Family Welfare, namely:
- 1. Short title and commencement -(1) These rules may be called the Ministry of Health and Family Welfare, Dr. Ram Manohar Lohia Hospital, Chief Nursing Officer (Group A Post) , Recruitment Rules , 2021.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application.- These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and level in pay matrix. The number of the said posts, their classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule.
- 4. Method of recruitment, age-limit, qualifications, etc. The method of recruitment, age-limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
- Disqualification. No person,
 - a. who has entered into or contracted a marriage with a person having a spouse living; or
 - b. who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the ex-servicemen and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.

Note 1: The departmental Nursing Superintendent of the Dr. Ram Manohar Lohia Hospital , New Delhi with five years of regular service in Consultation from Union Public Service Commission is necessary on each occassion.

Note2:-Period of deputation(including short-term contract) including period of deputation(including short-term contract) in another Ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years.

Note 3: The maximum age- limit for appointment by deputation including short-term contract shall not be exceeding fifty -six years as on the closing date of receipt of applications.
