Dear Chief Secretary,

Mission Indradhanush is a flagship programme of the Ministry of Health & Family Welfare (Government of India) launched in December 2014 which aims at increasing the full immunization coverage of children across the country. [This Ministry has received communication from Secretary, MoH&FW requesting for support and coordination of this Ministry to achieve the target of Intensified Mission Indradhanush (*copy enclosed*).]

2. In the PRAGATI review meeting held on 26th April, 2017, Hon'ble Prime Minister has directed the MoHF&W to reach the target of 90% full immunization by December 2018 instead of the earlier set year of 2020, with increased convergence with other Ministries with special focus on selected districts and urban areas. The MoHF&W has identified 118 districts, 17 urban areas and 52 districts of North East States where the Intensified Mission Indradhanush is to be carried out from October, 2017 (*list enclosed*).

3. Following areas have been identified by the MoHF&W where the support & coordination is expected from the Anganwadi Services Scheme in achieving the target of Intensified Mission Indradhanush:

- Sharing of data on beneficiaries with ANM/ASHA.
- AWW to support conducting head count surveys and assist in micro-plan development.
- Extra support needed from AWW in urban or other areas with no ASHAs.
- IPC with pregnant women for TT vaccination and infant vaccination.
- Monitoring of AWWs by CDPOs and DPOs.

4. In this connection, may I request you to issue necessary instructions to the officers dealing with the Anganwadi Services in your State/UT to provide their unstinted support to Mission Indradhanush as explained above. A copy of letter, dated 5th July 2017 received from Secretary, D/o Health & Family Welfare is also **enclosed** for reference.
