- 6. Intimation whether all the seats allocated to that Ministry have been fully utilized should be conveyed to this Department on most urgent basis. In the event of any default in this behalf, this Ministry may have no choice except to curtail the allocation, to the extent of the seat(s) lost or un-utilized, in the succeeding year.
- The two seats allocated to the Indian Council for Child Welfare should go to the eligible National Bravery awardees.
