

NOTIFICATION

G.S.R.- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules, regulating the method of recruitment to the posts of Health Inspector in Safdarjung Hospital of Delhi under Ministry of Health and Family Welfare namely:-

1. (1) These rules may be Safdarjung Hospital New Delhi, Health Inspector, Recruitment Rules, 2017.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Initial Constitution: The incumbent of the post specified in column 1 of the Schedule to these rules who were appointed on regular basis in the Safdarjung Hospital, New Delhi before the commencement of these rules shall be deemed to have been appointed under these rules and the services rendered by them in such post on regular basis shall be taken into account for the purpose of probation, confirmation and pension.

3. Number of post, classification, level in the pay matrix. – The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
4. Method of recruitment, age limit, qualification, etc. – The method of recruitment age limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
5. Disqualification. – No person, -
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax. – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
7. Saving - Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes Ex-servicemen and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.
