

G.S.R- In exercise of the powers conferred by the proviso to article 309 of the Constitution the President hereby makes the following rules regulating the method of recruitment to the post of Clinical (Child) Psychologist in Dr. RML Hospital, namely:-

1. Short title and commencement. - (1) These rules may be called the Ministry of Health and Family Welfare, Dr. Ram ManoharLohia Hospital, New Delhi Clinical (Child) Psychologist (Group 'A' post) Recruitment Rules, 2019.
(2) They shall come into force on the date of their publication in the Official Gazette
2. Number of post, classification, level in the pay matrix. - The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
3. Method of recruitment, age-limit, qualification, etc. - The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
4. Disqualification. - No person, -
(a) who has entered into or contracted a marriage with a person having a spouse living, or
(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
5. Power to relax. - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
6. Saving .- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.

Phil in Clinical Psychology from recognized University, registered from the Rehabilitation Council of India and two years of clinical experience in Paediatrics or developmental assessment in infants and toddlers.</p> <p>Note 1: Qualifications are relaxable at the discretion of the <u>Staff Selection Commission</u> or Competent Authority for reasons to be recorded in writing in case of candidates otherwise well qualified.</p> <p>Note 2: Qualifications regarding experience is relaxable at the discretion of the <u>Staff Selection Commission</u> or the Competent Authority for reasons to be recorded in writing, in case of candidates belonging to the Scheduled Castes or the Scheduled Tribes, if at any stage of selection the <u>Staff Selection Commission</u> or the Competent Authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.</p>
