2. The Letters of Intent (LoI) will be issued to the Colleges after receiving the approval of the competent authority calling for the following documents:

i. Bank Guarantee of required amount in favour of the Dental Council of India, New Delhi valid for the entire duration of the course from a Nationalised/ Scheduled Bank. For Dental College/ Institutions which are governed by State Government, an undertaking shall be made by the concerned State Government to provide funds in their Plan Budget regularly till facilities are fully provided as per the time bound programme in the DCI's norms against starting/ Increase in seats in the above said MDS courses.

ii. An undertaking to implement any decision of the Dental Council of India/ Central Government regarding payment of stipend to the PG students.
