#### **NOTIFICATION**

GSR- In exercise of the powers conferred by the proviso to Article 309, the President hereby makes the following rules regulating the method of recruitment to the post of Administrative Officer in the Central Leprosy Teaching and Research Institute, Chengalpattu, Tamil Nadu under Directorate General of Health Services, Ministry of Health & Family Welfare namely:-

- 1. <u>Short title and commencement.</u> These rules may be called the Central Leprosy Teaching and Research Institute, Chengalpattu, Tamil Nadu, Directorate General of Health Services, Ministry of Health and Family Welfare, (Administrative Officer)Group 'A' " Gazetted post, Recruitment Rules, 2017. They shall come into force on the date of their publication in the official gazette.
- 2. <u>Number of post, classification and scale of pay.</u> The number of post, its classification and the Pay Level in Pay Matrix attached thereto shall be as specified in Columns 2 to 4 of the schedule annexed to these rules.
- 3. <u>Method of recruitment</u>, age <u>limit</u>, <u>qualifications</u>, <u>etc.</u> The method of recruitment to the said posts, age limit, qualification and other matters relating to thereto shall be as specified in column 5 to 13 of the said schedule.
- Disqualifications. No person,
- (o) Who has entered into or contracted a marriage with a person having a spouse living ,or
- (p) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule

- 5. <u>Power to relax.</u> Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. <u>Saving.</u> Nothing in these rules shall affect reservations, relaxations of age limit and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes, Other backward Classes, Ex-Servicemen or any other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
