Major Events & Achievements

- 1. The National Medical Commission Bill which seeks to constitute a National Medical Commission with 4 Autonomous Boards under it to replace the Medical Council of India (IMC) was introduced in Lok Sabha on 29.12.2017.
- 2. The Dentists (Amendment) Bill, 2017 which seeks to remove mandatory requirement of nomination of member from Part B of the Dental Register has been introduced in the Lok Sabha.
- 3. A meeting between Hon'ble HFM and H. E. Dr. Roberto Morales Ojeda, Minister of Public Health of Cuba was held to discuss bilateral health issues at New Delhi on 6th December, 2017, followed by signing of Memorandum of Understanding between Ministry of Health & Family Welfare of India and the Ministry of Public Health of Cuba on cooperation in the field of Health and Medicine.
