OFFICE MEMORANDUM

Subject: Renewal of empanelment of "Rathi Eye Hospital, Rohtak (Haryana)" under CS (MA) Rules, 1944 under CS (MA), Rules, 1944-rgarding.

The undersigned is directed to refer letter dated NIL regarding renewal of empanelment of "Rathi Eye Hospital, Rohtak (Haryana)" for treatment of Central Government Employees and their family members under Central Services (Medical Attendance) Rules, 1944. The said proposal has been examined in this Ministry and found to be in order. It has been decided to renew the empanelment of "Rathi Eye Hospital, Rohtak (Haryana)" under CS (MA) Rules, 1944 for a period of 02 years from the date of signing of fresh MOU on the same terms and conditions laid down in O.M. No. S. 14021/65/2017-EHS dated 13th September, 2019.

2. The hospital stands re-empanelled under CS (MA) Rules, 1944 for a period of 2 (two) more years from the date of issue of this O.M.

3. The authorities of "Rathi Eye Hospital, Rohtak (Haryana)" will have to enter into a fresh agreement with the Government of India to the effect that the Hospital will charge from the Central Government employees at the rates fixed by the Government and they will have to sign a fresh Memorandum of Understanding (MoU) failing which the Hospital will be de-recognized (two original copies of MoU duly signed by the Hospital to be sent for acceptance). Subject to above, the Hospital can start treating Central Government employees covered under CS (MA) Rules, 1944.

4. A communication in acceptance of the Para 3 above may be sent to the undersigned within a week from the receipt of this Office Memorandum.
