G.S.R..... – In exercise of the powers conferred by the proviso to article 309 of the Constitution, in suppression of the Safdarjung Hospital, New Delhi, Recruitment Rules, 1984, Dr. Ram Manohar Lohia Hospital, 1983 in so far as it relates to the Group'B' post of Assistant Administrative Officer and Store Officer, except as respects things done or omitted to be done before such suppression, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Administrative Officer in the Sajdarjung Hospital, Dr. Ram Manohar Lohia Hospital, Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital and Kalawati Saran Children's Hospital, New Delhi, namely:-

1. Short title and commencement. – (i) These rules may be called the Ministry of Health and Family Welfare, the Central Government Hospitals in New Delhi, Assistant Administrative Officer (Group – 'B' Post) Recruitment Rules, 2024.

(ii) They shall come into force on the date of their publication in the Official Gazette.

Number of posts, classification and level in pay matrix. – The number of the said posts, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule.

3. Method of recruitment, age-limit, qualifications, etc. – The method of recruitment, agelimit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.

4. Disgualification. - No person, -

1. who has entered into or contracted a marriage with a person having a spouse living ; or

2. who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax. – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving .- Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation: i) Officers of the Central Government or State Government, Union Territories Administration, Autonomous or Statutory organization, Public Sector Undertakings, University or Recognized Research Institution : a)(i) Holding analogous posts on regular basis in the parent cadre or department: or or ii) officials in Level -06 of pay Matrix (Rs. 35400-112400) with five years regular service in the parent cadre or department. and (B) possessing the following educational qualifications and experience: - 1. Bachelor's degree from a recognized University. 2. Having two years' experience of Establishment and general administration work. Note 1: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for appointment by promotion.
	Note 2: The period of deputation including period of deputation in

another Ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.
Note 3 : The maximum age- limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

(13)(12)Consultation with UPSC is not necessary Promotion Committee (for Departmental considering promotion) consisting of :-1. Directorate General of Health Service -Member; 3. Deputy Director in Directorate General of Health Service looking after the work of concerned Hospitals. -Member.
