- 7. The Expenditure covered by this sanction will be met from the funds provided under Demand No.48 3601 –Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02789 –Scheduled caste sub Plan (Minor Head), 35- Public Health-Prevention and Control of Diseases, 3523—Flexible Pooi for Communicable Diseases GC, 352331 –Grants in Aid General (Plan) for the year 2015-16.
