The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 796 - Scheduled Tribe Sub-Plan (Minor Head); 33 - FW-Direction & Administration (Sub-Head); 33.02.-IM-Sub-Centres; 33.02.31-Grants-in-aid – General in Demand No.48 – Health & Family Welfare during 2015-16.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
