- The Sanction order is being issued in accordance with Rule 206 to 215 of General 6. Financial Rules, 2005.
- The Expenditure covered by this sanction will be met from the funds provided under 7. Demand No.48 - 3601 -Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head ) 02263 -Public Health-Prevention and Control of Diseases (Minor Head), 08-Flexible Pool for Communicable Diseases, 0810 EAC, 081031 -Grants in Aid General (Plan) for the year 2015-16.
