Sub.: Release balance of First Installment of Grants in Aid for Flexible Pool for communicable Diseases to Bihar State under Revised National TB Control Programme during the year 2015-16.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs.4,55,31,000/- (Rupees Four crore fifty five lakh thirty one thousand only) to the State of Bihar towards balance of first Installment of Grants-in Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2015-16 as lump sum for undertaking various activities for implementation of RNTCP in the State.

- The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan Finance Division) Vide their O.M. No.10(I)-PF-1/76 dated 22th January, 1977 and is to be paid in cash.
- The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, Gol.
- The State shall ensure that 25% of its share based on release of funds by Gol is credited to appropriate accounts.
- The state shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMR/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
- The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The Expenditure covered by this sanction will be met from the funds provided under Demand No.48 – 3601 –Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02789 –Scheduled caste sub Plan (Minor Head), 35- Public Health-Prevention and Control of Diseases, 3524—Flexible Pool for Communicable Diseases EAC, 352431 –Grants in Aid General for the year 2015-16.

8. The Grants -in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1965.
