The Expenditure covered by this sanction will be met from the funds provided under Demand No.48 3601 –Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02263 –Public Health-Prevention and Control of Diseases (Minor Head), 08-Flexible Pool for Communicable Diseases, 0810 EAC, 081031 –Grants in Aid General for the year 2015-16.
