The Expenditure covered by this sanction will be met from the funds provided under Demand No.48 3601 –Grants in Aid to state Government (major Head), 02- Grants for State Plan Scheme (Sub-Major Head) 02796 –Scheduled Tribes Sub Plan (Minor Head), 35- Public Health Prevention and control of Diseases, 3523 Flexible Pool for Communicable Diseases GC, 352331 –Grants in Aid General (Plan) for the year 2015-16.
