The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants State Plan Scheme (Sub-Major Head); 789 - Scheduled Caste Sub Plan (Minor Head); 33 - FW-Direction & Administration (Sub-Head); 33.03 - IM- Urban FW Centres; 33.03.31- Grants-in-aid - General in Demand No.48 - Health & Family Welfare during 2015-16.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.11/66 dated 9.10.1966.

5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-644 dated 25.6.2015.


