New Delhi. Release of Grant-in-aid (Plan) to State Government of Kerala under Rashtriya Swasthya Birna Yojana Sub:

Sir.

(RSBY) to be undertaken for General category during the year 2014-15. i am directed to convey the sanction of the President of India to release Rs.9,66,85,062/-(Rupees Nine Crore Sixty Six Lakh Eighty Five Thousand and Fifty Two only) to the State Government of Kerala towards Central Government's share of premium in respect of issue/renewal of smart cards of BPL femilies and others eligible Categories Auto Rickshaw Drivers & Taxi Drivers, Street Vendors, Domestic Workers, Beedi Workers, MGNREGA, Mine Workers, Rag Pickers, Rickehaw Pullers & Sanitary Workers, as beneficiaries under Rashtriya Swasthya Bima Yojana to the State Government of Kerala on the following terms and conditions:

- Grant-in-eid shall be used for the purpose for which sanction is given. An annual utilization certificate (in (i) form GFR 19A ) shall be furnished that the Contribution has been utilized for the purpose for which it was
- The accounts relating to this sanction shall be open to audit by the Comptroller and Auditor General of (ii) India or by the representatives from the Internal Audit of the Ministry and also for verification by Officers of the Ministry or State Government at any point of time. (iii)
- An audited statement of accounts (in duplicate) shall be furnished to this Ministry within three months of the expiry of the time prescribed for which Grant-in-aid was released. (iv)
- Utilization Certificate as per Form 19 A of General Financial Rules in respect of the total Grant-in-aid in a financial year shall be furnished to the Ministry by the State Government. (v)
- No part of the grant will be utilized for meeting administrative/establishment expenditure. (i i)
- The Government may lay down any other condition prior to the release of the Grant-in-aid. (Grant No- 62) Waln
