The project development objective is to improve the information available to the Government Health Services and Private Health Care providers on a set of high-priority diseases and risk factors, with a view to improve on the ground responses to such diseases
- The State shall not make any changes in allocations or re-appropriations among different 3. components/ activities without approval of the, MOH & FW, Government of India.
- The State shall ensure that 25% of its share based on release of funds by Government of 4. India is credited to the appropriate Accounts.
- The State shall ensure completion of Delegation of Administrative and Financial Powers 5. during the current financial year and funding of Integrated Disease Surveillance Programmes will be based on clear delegation as per earlier directions.
- The State shall follow all the financial management systems under Integrated Disease 6. Surveillance Project and shall submit within six months of closing of financial year Statutory Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs / SOEs and Statement of Fund Position showing unspent balances, funds released as advances, interest earned on unspent balance.
- The remuneration of contractual staff may be paid, provided a provision for the same had 7. been made in the State PIP and approved by the NPCC for the current financial year.

- The fund to the Karnataka State has been released from Budget Estimate (Domestic Budget 8. Component) for the financial year 2015-16 of MOH&FW, Government of India.  - B. PUCs/FMRs/SOEs upto 31st March 2015 have been received from the State.
 - C. UC is not pending for the year 2013-14 from Karnataka State. (Applicable only while releasing the second instalment and statutory audit)
- 9. The accounts of the grantee institutions/organizations shall be open to inspection by the sanctioning authority and audit both by the C & AG of India under the provisions of CAG (DPC) Act, 1971 and internal audit wing of the office of CCA, MOH & FW.
