- 4. The State shall ensure that 25% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The State\_shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules,
- 7. The expenditure covered by this sanction will be met from the funds provided under Demand No. 48, Major Head–3601-Grant-in-aid to State Governments, Minor Head-02246-Family Welfare Reproductive & Child Health, Sub-Head-02-National Urban Health Mission-Flexible Pool, 0201-National Urban Health Mission, 020131-Grants-in-aid General during 2015-16 (Plan).
- 8. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
