
Subject:- Release of 1st installment of grants for creation of Capital Assets under NUHM Flexible Pool - STSP
(Scheduled Tribes Sub Plan) for the year 2015-16.

Sir,

I am directed to convey the sanction of the President of India to the payment of Rs.5,00,000/- (Rupees Five lakh only) to the State of Tamil Nadu towards the First installment of grants for creation of Capital Assets for NUHM Flexible Pool during 2015-16.

- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-1/76 dated 22nd January, 1977 and is to be paid in Cash.
- The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- ~~The State shall ensure that 25% of its share based on release of funds by GOI is credited to appropriate accounts.~~
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The expenditure covered by this sanction will be met from the funds provided under Demand No. 48, Major Head-3601-Grant-in-aid to State Governments, Minor Head-02796-Scheduled Tribal Sub Plan, 34-FW-RCH, Sub-Head-3407-National Urban Health Mission-Flexible Pool-National Urban Health Mission, 340735-Grants for creation of capital assets during 2015-16 (Plan).
- The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.11/66 dated 9.10.1966.
- This sanction issues with the concurrence of Finance Division vide Dy. No. C-669 dated 1st July, 2015.
