I am directed to convey the sanction of the President of India to the payment of Rs.1.36 Crore (Rupees One Crore Thirty Six Lakhs Only) to the State of Jammu & Kashmir towards the First installment of grants-in-aid for Health System Strengthening under NRHM during 2015-16.

- 2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
- 3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- 4. The State shall ensure that 25%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02 Grants for State Plan Schemes (Sub-Major Head); 796 Scheduled Tribes Sub Plan (Minor Head); 34- NRHM-RCH Flexible Pool (Sub-Head); 34.11- Mission Flexible Pool (New); .34.11.35- Grants for Creation of capital assets in Demand No.48 in Demand No.48 Health & Family Welfare during 2015-16 (Plan).
