- The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601 - Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 796 - Scheduled Tribes Sub Plan (Minor Head); 34-NRHM-RCH Flexible Pool (Sub-Head); 34.09- RCH Flexible Pool (New); .34.09.31-Grants-in-aid - General in Demand No.48 - Health & Family Welfare during 2015-16 (Plan).
