Sub: Release of Grant-in-aid (Plan) to State Government of Haryana under Rashtriya Swasthya Bima Yojana (RSBY) to be undertaken for General category during the year 2014-15.

Sir,

I am directed to convey the sanction of the President of India to release **Rs. 4,38,13,136/-** (Rupees Four Crores Thirty Eight Lakhs Thirteen Thousand One Hundred Thirty Six only) to the State Government of Haryana towards Central Government's Share of Premium in respect of issue / renewal of smart cards of BPL families as beneficiaries under Rashtriya Swasthya Bima Yojana for the period 2013-14 and balance outstanding of previous years, which is released now, to the State Government of Haryana on the following terms and conditions:

- (i) Grant-in-aid shall be used for the purpose for which sanction is given. An annual utilisation certificate (in form GFR 19A) shall be furnished that the contribution has been utilised for the purpose for which it was sanctioned.
  - (ii) The accounts relating to the sanction shall be open to audit by the Comptroller and Audit General of India or by the representatives from the Internal Audit of the Ministry and also for verification by Officers of the Ministry or State Government at any point of time.
  - (iii) An audited statement of accounts (in duplicate) shall be furnished to this Ministry within **three months** of the expiry of the time prescribed for which Grant-in-aid was released.
  - (iv) Utilisation Certificate as per **Form 19A of General Financial Rules** in respect of the total Grant-in-aid in a financial year shall be furnished to this Ministry by the State Government.
  - (v) No part of the grant will be utilised for meeting administrative/establishment expenditure.
  - (vi) The Government may lay down any other condition prior to the release of the Grant-in-aid.
2. The Ministry of Labour & Employment vide letter no. M-21021/25/2015-RW dated 25.06.2015 has transferred Rs. 350 Crores under authorisation mode to this Ministry. The photocopy of this aforesaid letter is attached for your ready reference and record, please.

3. It is certified that no Utilisation is pending in respect of the State mentioned in the Sanction Order as per requirement.

The amount of Rs. 43813136/- (Rupees Four Crores Thirty Eight Lakhs Thirteen Thousand One Hundred Thirty Six only) may be transferred to State Government of Haryana through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.
5. It shall be the responsibility of the State Government of Haryana and the SNA to exercise due diligence as per norms prescribed for scrutiny of the documents and accuracy of data before release of Central Government's Share of Premium to the Insurer. Any excess amount received towards Central Government's Share of Premium shall be refunded back to the Central Government.
6. This sanction is issued with the concurrence of Integrated Finance Division, which they have provided, vide their concurrence No. C-871 dated 29.07.2015.
