Subject: - Promotion of Digital Payments in Healthcare Sector.

Dear colleague,

As you may be aware, promotion of digital payments has been accorded highest priority by the Government and is one of the key highlights of the Union Budget 2017-2018. Accordingly, a pan-India target of total 2,500 crore digital transactions through five payment modes namely UPI, USSD, Aadhar Pay, IMPS and Debit cards has been announced for the year 2017-18. The target is further divided between Central Ministry/Departments and States as 1500 crore and 1000 crore transactions respectively. Further, 91 crore digital transactions have been allocated to Healthcare Sector.

2. MeitY has been designated as the Nodal Ministry to overall coordinate and monitor the promotion of digital payments and transactions. As informed by MeitY, this initiative is being undertaken in form of a Mission under periodic and regular review by PMO. A number of meetings have been held under chairmanship of Secretary, MeitY and AS, MeitY over the last few weeks with various Ministries/Departments for discussion/deliberation on this matter.

3. In this regard, the Ministry has already issued advisories/letters to all the states/UTs Govt. as well as central Govt. Hospitals/Autonomous institutes with regard to promotion of digital payment. We had requested you to submit the action plan in the prescribed format shared with you earlier with the firm timelines, for enabling digital transactions to ensure 100% achievement of targets. All facilities/Hospitals were advised install facilities for receiving payment in digital mode at various touch points having citizen interface such as registration counters, diagnostics centres, medical stores, pharmacies, canteen etc.

4. In the meeting of Digital Payments Committee was held under the Chairmanship of Shri. R K Vats, AS&DG, MoHFW, it was decided that the target of 91 crore should be broadly distributed among States based on the population. The allocated targets to States for FY17/18 are as per *Annexure A*.

5. As there is continuous review taking place at the level of Cabinet Secretary and Secretary (Meity), you are requested to submit the progress being made so far in the prescribed format along with the no. of digital transactions pertaining to net banking, mobile banking, mobile payment application etc. in the *enclosed template (Annexure B)* within a week, so that the same could be presented to the apex committee of MeitY.
