**ORDER**

Subject: Establishment of new medical college at Meerut (Mulayam Singh Yadav Medical College & Hospital) by KSD Charitable Trust, Meerut with an annual intake of 150 MBBS students u/s 10A of the IMC Act, 1956 for the academic year 2017-18.

Whereas the KSD Charitable Trust, Meerut made application for establishment new medical college at Muzaffarpur in the name & style of Mulayam Singh Yadav Medical College & Hospital for the academic session 2017-18 to the Ministry. The Ministry forwarded the application to MCI for evaluation and making recommendation to the Ministry u/s 10 A of IMC Act, 1956 for the academic session 2017-18;

2. Whereas, an assessment to the proposed College was carried out by the Council's Assessors on 10<sup>th</sup> & 11<sup>th</sup> January, 2017. The assessment report (10<sup>th</sup> & 11<sup>th</sup> January, 2017) alongwith letter dated 10.01.2017 received from the appointed team of Council Assessors was considered by the Executive Committee at its meeting held on 13.1.2017 and noted the following :-

***"In referencce to MCI(34(41)/2016-Med./E-66/ dated 05.01.2017, we the assessors reached the institute Mulayam Singh Yadav Medical College & Hospital at Meerut, Uttar Pradesh by KSD Charitable Trust for Assessment of the Physical and the other teaching facilities available for 150 seats u/s 10A of the IMC Act, 1956 for the academic year 2017-18 at 9.45 AM on 10.01.2017.***

***Principal Prof. Sarat Chandra Das MD (Microbiology) and Dr. Ashwani Sharma, Director General of this Institute was present. Principal received the letter at 10AM on 10.01.2017.***

***They were not in position to conduct the inspection process due to sudden demise of their trustee's father and declared holiday on 10.01.207. Hence we could not conduct the assessment process."***

3 Whereas the Medical Council of India (MCI) vide its letter dated 31.01.2017 returned the application recommending to the Central Government to disapprove the scheme of establishment of new Medical College at Meerut by KSD Charitable Trust, Meerut for the academic year 2017-18;



4. Whereas, u/s 10 A (4) of IMC, Act, 1956, the Ministry afforded an opportunity of hearing to the college before Hearing Committee on 20.02.2017. The Hearing Committee recommended to accept the recommendation of MCI for disapproval.
6. Whereas the Ministry accepted the recommendation of MCI and disapproved the applications of the college for establishment of new college at Meerut by KSD Charitable Trust, Meerut for the academic session 2017-2018 vide letter dated 31.05.2017;
7. Whereas the college filed W.P (C) No. 7070 of 2017 & C.M. Nos. 29390-91 of 2017 in the Hon'ble Delhi High Court and the Hon'ble Court on 22.08.2017 passed the following order:-

***".....The prayers made in the petitions are allowed. Respondent No.1 will grant a hearing to the petitioner institutes; the order dated 31.05.2017 not being a reasoned order, Central Government will afford an opportunity of hearing and pass a reasoned order within 10 days from today.***

8. Now, in compliance with the above direction of Hon'ble High Court, the Ministry granted hearing to the college on 25.08.2017. The Hearing Committee after considering the record and submission of the college submitted its report to the Ministry with the following findings:-

***The college has submitted that the first day of MCI assessment i.e. 10.01.2017 was declared a college holiday due to demise of father of one of the trustees. They requested the assessors to verify the hospital infrastructure on the first day and keep college inspection on the following day. This was obviously not agreed by MCI assessors since the surprise element in an inspection is for faculty/residents/patients and not the physical infrastructure.***


***The Committee perused the documents furnished by the college during the hearing. The college representatives could not respond to many basic queries and the evidence was not very satisfactory.***

***Letter of permission for establishment of a medical college can be issued only after the facilities in terms of faculty, residents, clinical material and infrastructure have been verified through an MCI assessment.***

***The Committee agrees with decision of the Ministry to disapprove the college for the academic year 2017-18.***



10. Accepting the recommendations of the Hearing Committee, the Ministry reiterates its earlier decision dated 31.05.2017 to disapprove the scheme of establishment of new Medical College at Meerut by KSD Charitable Trust, Meerut for the academic year 2017-18;
