Ministry of Health & Family Welfare intends to engage services of Principal Consultant (Engineering) as detailed below, on contract basis for a initial period of 11 months liable for extension based on functional requirements and suitability connected with various activities related to Pradhan Mantri Swasthya Suraksha Yojana (PMSSY).

- i) Post name – Principal Consultant (Engineering)
- ii) No. of vacancies – 1 (One)
- iii) Qualification – B.E. or B. Tech in Civil Engineering from recognized University or IIT or NIT. ME/M Tech in relevant Engineering field or in construction management will have added advantage.
- iv) Minimum experience – 25 years. Relevant experience in planning, tendering, execution and contract management of engineering works for large size/multi storeyed buildings or hospital and other health care projects. Experience of handling Central Government Civil Construction Projects and candidates having knowledge of CPWD/Government procedures with respect to construction projects would be preferred.

Candidate should have worked in the rank of Chief Engineer or above in CPWD or any other Central/State Government Organization for a period of atleast 2 years.

- v) Work responsibilities
 - (a) To examine/review concept plan(s)/detailed project report(s)/estimates received in Ministry and make necessary suggestions/recommendations as advice.
 - (b) To examine/review tender document(s) for engineering works and submit advice.
 - (c) To examine all technical issues related to an arising during implementation of engineering works in PMSSY/MoHFW projects and submit advice.
 - (d) To assist and to tender advice in evaluation of specifications and in quality assurance.
 - (e) To evaluate work progress against planned schedule and update construction schedule and submit advice.
 - (f) To identify potential problem areas, likely causes of delay/ slippage and suggest preventive and contingent action and submit advice.
 - (g) To work in coordination with other consultants and/ or units of Division.
 - (h) Any other works which may be assigned form time to time.

- vi) Age limit – Persons upto age of 65 years including those retired from Central Government/State Government /Armed Forces /CPWD /CPSU meeting eligibility requirements can apply. Those coming under purview of DG Resettlement may also apply
- vii) Remuneration – consolidated remuneration of Rs. 1,00,000/- (Rs. one lakh) per month. Rise in remuneration for engaged consultant beyond a year will be given as per Ministry's existent policy.
- viii) Initial period of contract – 11 months – liable to be extended or curtailed depending upon individual's performance and need of the project at the discretion of the Ministry.
