Essential qualifications and eligibility for each post will be as per All India Institute of Medical Sciences, New Delhi norms and Indian Nursing Council (INC)

**III. Application Process:** Detailed advertisement is hosted at the website of AIIMS Bhopal, <u>www.aiimsbhopal.edu.in</u> & <u>www.aiimsbhopal.nic.in</u> and <u>www.mohfw.nic.in</u>. The application form has to be filled online at <u>www.jobs.aiimsbhopal.edu.in</u>

**IV. Application fee:** Application fee for General/OBC candidates is Rs 500/-, fees for SC/ST candidates is Nil. Fees shall be paid through NEFT/online transfer only. Account details: Bank of Baroda Account No. 45340100000148, IFSC code BARBOAIIMSX. This fee once remitted will not be refunded.

**V. Applicants from other Institutions:** Those who are working in Central / State Government / Semi Government Autonomous Institutes will have to submit "No Objection Certificate" from their respective Organization along with their application at the time of interview only. Please do not post or send hard copies.

**VI**. Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Caste certificates and experience certificates etc. may be annexed to the hard copy of the application to be produced in original along with photocopy for verification at the time of interview.

#### VII. Age:

- 1. Age limit refers to completed age in years as on 1<sup>st</sup> Jan 2014
- 2. Age relaxation of 5 years for SC/ST, 3 years for OBC candidates and up to 5 years for persons already working in AIIMS Bhopal in any capacity will be admissible.
- 3. In the case of Orthopaedic Physical Handicapped (OPH \*) candidates age relaxation up to maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates.

#### VIII. Reservation:

- OBC Candidates will attach certificate in Annexure V from the prescribed authority for Central Government posts along with certificate that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year i.e. 1<sup>st</sup> July, 2012 (AN).
- 2. For SC/ST Certificate should be issued by Tehsildar or above rank officer in format of State/Central Government.
- 3. OPH \* Certificate must be issued by District Board of State/Central Government hospital/ Chief Medical Officer

- **IX. Short Listing:** Based on bio-data, the Search cum Selection Committee may short-list candidates for interview or they may be asked to appear in a written examination in case of large number of applicants. #### **TERMS & CONDITIONS**

- **1.** The period of employment will be initially for a period of 11 months or till regular incumbent joins the Institute whichever is earlier. The services of the appointee are liable to be terminated by either side by giving 30 days' notice or salary in lieu thereof. The appointment is purely contractual in nature and does not confer any right for regularization or permanent absorption.
- **2.** Remuneration will be given per month consolidated. The appointee will not be entitled to any allowances, financial benefits or concessions as admissible to government employees. Income tax will be deducted at source on monthly basis.
- **3.** Leave: The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.
- **4.** Canvassing of any kind will lead to disqualification.
- **5.** The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- **6.** The appointment is full time and private practice of any type is prohibited.
- **7.** He/She may have to work in shifts and can be posted at any place in the institute.
- **8.** He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- **9.** The candidate should not have been convicted by any Court of Law.
- **10.** In case any declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action as deemed fit by the appointing authority.
